3. Documents in original with one set photocopy
 - (i) Date of Birth Certificate – Matric / Birth Certificate
 - (ii) Educational Qualifications Certificate along with Mark sheets of all years / semesters of following examination.
 - a) Matriculation
 - b) Degree/Post Graduate Degree/Diploma (as applicable)
 - c) Wherever specialization is mentioned, subjects in specialization required should have been part of the examination cleared and find mention in the final mark sheet / degree certificate. And in case specialization is not mentioned, it should be certified by the University/Institution attended.
 - (iii) Proof of norms adopted by the University/Institute to convert CGPA/OGPA/DGPA into percentage (wherever applicable).
 - (iv) “No Objection Certificate” from your present employer, in case you are already employed in State/Central/Public Sector/Autonomous undertakings.
 - (v) Caste Certificate (applicable in case of SC/ST/OBC-Non Creamy Layer) in prescribed GOI format from Competent Authority.
