Further, the candidates who were issued Offer of Appointment for Field Supervisor (Elect/Civil) under same project and have undergone pre-employment medical examination need not to appear for the same again.

The medical examination shall be conducted in accordance with POWERGRID Medical Fitness Standards as available on our website in our empanelled hospital. The candidates who clear medical examination shall be required to join immediately. The candidates are also advised to bring duly filled in enclosed formats of Character certificate (to be issued by two different persons) and Attestation form (6 copies to be filled in original to be submitted at the time of joining). **Further, the candidates who were allowed provisionally and have given undertaking to submit their detailed experience certificate are required to bring their original experience certificate along with one self- attested photocopy for joining; without which their joining formalities will not be completed.** If any candidate fails to report by the stipulated date for pre-employment medical examination and subsequent joining, his candidature shall be summarily withdrawn and cancelled without any further notification. Thereafter, next candidate in waiting panel shall be issued Offer of appointment.
